DETAILED ACTION

Continued Examination Under 37 CFR 1.114

1. A request for continued examination under 37 CFR 1.114, including the fee set forth in 37 CFR 1.17(e), was filed in this application after final rejection. Since this application is eligible for continued examination under 37 CFR 1.114, and the fee set forth in 37 CFR 1.17(e) has been timely paid, the finality of the previous Office action has been withdrawn pursuant to 37 CFR 1.114. Applicant's submission, RCE, filed on 08/02/12 has been entered.

Allowable Subject Matter

2. Claims 1, 4-6, 8-11, 14, and 18-27 are allowed.
3. The following is an Examiner's statement of reasons for allowance in combination with other claim limitations:

Independent claims 1, 14, and 20, when considered as a whole, are allowable over the Prior Art of record including the IDS filed on October 16, 2012. Specifically, the Prior Art fails to teach or suggest the system for providing assistance regarding the user-performed gesture is capable of receiving data captured by the camera, the data corresponding to a user motion or pose, analyzing the data to produce the output corresponding to whether the data corresponds to input recognized by the system, wherein determining from the output that it is unlikely that the user correctly performed the user motion or pose that invokes the input recognized by the system, determining from the output that the user likely intended to perform the user motion or pose that invokes the input recognized by the system, adjusting the output to have the new value,

the new value being more indicative of invoking the input recognized by the system than the old value is indicative of invoking the input recognized by the system, and send the adjusted output to the application that is configured to process the input recognized by the system.
